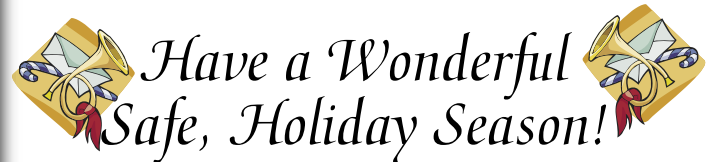
Save the date...April 17, 2008. It will be at the New and Improved Norris Conference Center...same location-the old Northcross Mall, they are just remodeling and making it bigger.
